OUICK INFORMATION

CASH FOR COLLEGE IS WAITING FOR YOU

- Each year, the State of Maryland awards appproximately \$100 million in need-based grants, scholarships, and loan repayment programs.
- Every year, more than 65,000 students, just like you, receive money that ranges from \$200 per year to over \$17,500 per year.
- Maryland scholarships and grant programs are available to eligible students who plan to attend a public or private Maryland two- or fouryear college, university or private career school.
- State financial aid can be used by both part-time and full-time students at the undergraduate and graduate level.

Here's just a sample of available scholarships and grants:

Howard P. Rawlings

Educational Assistance Grant

-The State's largest financial aid program helps low- and middle-income students, based upon financial need, attend a two-year or four-year Maryland institution.

Howard P. Rawlings

Guaranteed Access Grant

-When combined with a Federal Pell Grant, the program will pay the cost of attending a public two-year or four-year Maryland college. The maximum award of \$17.500 can be used at independent institutions too.

QUESTIONS & ANSWERS

Q. Am I eligible for money for college?

- A. You must be a Maryland resident to qualify for State scholarships and grants.
- Q. Do I have to pay back the money once I graduate from college?
- A. No. you don't have to pay back State financial aid; however, some programs require you to work in a specific field or Maryland region for a certain amount of time after you graduate. The Office of Student Financial Assistance (OSFA) can answer your questions about these service requirements.
- Q. Do I have to go to a Maryland college or university in order to receive State financial aid awards?
- A. There are two cases in which students who attend an out of state institution may also be eligible to receive the Legislative Scholarships: (1) Student must require disability accommodations that are not offered in the State of Maryland; or (2) Student must plan to enroll in an postsecondary academic program that is not offered in the State of Maryland.

Q How do I apply?

A. To apply for most State scholarships and grants you must fill out the Free Application for Federal Student Aid (FAFSA) by March 1st each year. You can get this application online in January at www.fafsa.gov. Some scholarships require additional applications. Applications are available at:

Q. When should I apply?

- A. Deadlines may be different for each program. Read the chart on the inside of this brochure for details. It's smart to apply early.
- Q. Am I guaranteed financial aid?
- A. Applying early will improve your chances: however, aid is based on your eligibility and the availability of funds.
