The **Near Completer Grant** is available for the 2019-2020 academic year to eligible applicants **not** currently enrolled at a post-secondary institution, but who now plan to re-enroll at an institution to finish their degree.

Eligible applicants must have previously attended a: ☐ public two-year post-secondary institution or ☐ public four-year post-secondary institution (*please check one*) and **completed** a required number of college credits, having previously earned a cumulative **minimum grade point average of 2.0**:

- If you have earned at least 45 credits, you may be eligible to complete your Associate Degree
- If you have earned at least 90 credits, you may be eligible to complete your Bachelor's Degree.

Transcripts:

If you are a student who wants to complete your Associate Degree, attach a copy of your transcript/transcripts showing that you have completed at least 45 credit hours.

If you are a student who wants to complete your Bachelor's Degree, attach a copy of your transcript/transcripts showing that you have completed at least 90 credit hours.

NOTE:

Applications will not be considered if received after the deadline of **December 23, 2019**. **Be sure to CONFIRM you are forwarding a complete and official transcript. Photocopies or website print outs are not acceptable.**
