MARYLAND HIGHER EDUCATION COMMISSION (MHEC) 2022 DATA BOOK

General Notes

Race/ethnicity data are reported in alignment with National Center for Education Statistics requirements. Individuals reporting Hispanic ethnicity are always reported as Hispanic regardless of any racial category identified. Individuals identifying as non-citizens are always reported as foreign/non-resident alien reparalless of any race/ethnicity identified.

Institutions report gender to MHEC in four categories: "male"; "female"; "unknown, male assigned"; and "unknown, female assigned." Institutions randomly assign students who report a gender other than male or female, or whose gender is unknown, to either the "unknown, male assigned" or "unknown, female assigned" categories. MHEC reporting includes these randomly-assigned students in the respective category to which they have been assigned by the institution.

The data MHEC uses for the Data Book comes in multiple formats. For some analysis, MHEC uses de-identified unit record data (name, address, and other Personally Identifiable Information are stripped) to merge data files (financial aid data and enrollment data, for example) using a scrambled unique identifier based on institutional submissions. This process may result in some undercounting due to inconsistent unique identifier data provided by the institution. Other data are provided to MHEC in aggregated format and are not reported at the unit-record level.

All figures are correct as of time of publication.

Asterisks (*) indicate suppressed data (n < 10) to protect student privacy. Complementary suppression may be applied for further protection.

Comparative Statistics

To produce nationally comparable data, the enrollment and degree data within this table are based upon Chronicle of Higher Education analysis of data reported to the National Center for Education Statistics (NCES) through the Integrated Postsecondary Education Data Survey (IPEDS). These figures may differ slightly from those produced using the MHEC Enrollment Information System and Degree Information System.

Figures may not sum to 100% due to rounding.

The racial/ethnic minority category includes African American, Asian, Hispanic, American Indian/Alaska Native, and Native Hawaiian/Pacific Islander students and students identifying as Two or More Races. It does not include white students or students in foreign and/or unknown categories. The underrepresented minority category includes African American, Hispanic, and American Indian/Alaska Native students.

The "Private Institutions'" share of campus enrollment distribution includes private non-profit 2-year institutions, private non-profit 4-year institutions, private for-profit 2-year institutions, and private for-profit 4-year institutions.

Figures for State spending on student financial aid utilize expenditures data produced by the National Association of State Student Grant and Aid Programs (NASSGAP).

Students

University of Maryland Global Campus figures include both stateside and overseas enrollment.

Students may be enrolled at more than one institution. They are included in enrollment figures for each institution at which they are enrolled.

Data include all degree- and non-degree-seeking students enrolled in credit courses.

Data from Lincoln College of Technology and Reid Temple Bible College are not included in enrollment figures due to errors in institutions' data submissions.

Enrollment files represent student enrollments as of the institution's official term freeze/census date, which typically represents the final date of which students may register for classes. Figures from later in the term may reflect different enrollment counts.

This report defines undergraduate and graduate students by cumulative credit earned as of term freeze/census date. Undergraduate student counts include high school students dually enrolled in both high school and for-credit college courses.

Full-time and part-time enrollment status is defined by institutions based on total semester hour credit load as of term freeze date. Generally, undergraduate students must enroll in at least 12 credit hours and graduate students at least 9 hours to be considered full-time.

Maryland residents are identified based upon their place of residence at the time of application to the institution.

Race/ethnicity data include full- and part-time students enrolled in undergraduate, graduate, and professional courses.

Student age is determined based upon year of birth. For the Fall 2020 semester, students are identified as 25 or older if they were born at any time during the 1995 calendar year.

Maryland public institutions include community colleges and four-year public colleges and universities.

The need for remediation is determined by individual institutions. Remedial assessment is based upon students' status at the time of entry.

Recent Maryland public high school graduates are defined as those graduating from a Maryland public high school, identified using the College Board School Code, who graduated in the 2018-2019 academic year and first enrolled in a higher education institution in Maryland in Fall 2019. Analysis relies on high school graduation date and reporting of remedial assessment data; missing data for these variables may result in underreporting.

Maryland residents whose county of residence is unknown are included in institution-level remedial data, but excluded from reporting by Place of Residence.

The counts of students identified as needing remediation may be underreported (such as the value of 0 for Coppin State University) due to misalignment in the institution's policies on identifying students for remediation and the definitions used in the data collection.

Salisbury University and St. Mary's College of Maryland do not offer remedial coursework.

Pell enrollment figures include undergraduate students receiving Pell awards during FY 2020 who were enrolled during the fall semester of 2019. Students may have received a Pell grant at more than one institution; they are included in figures for each institution at which they received the

The percentage of undergraduate students receiving Pell grants represents the total population of all undergraduate students enrolled. Dual enrollment students are not included.

Retention, Graduation, and Transfer

Retention rates at four-year public colleges and universities give the percentage of the Fall 2019 first-time, full-time undergraduate cohort who returned to the same institution in Fall 2020. Pell grant recipients are students in the Fall 2019 analysis cohort who received Pell at any time during the 2019-20 academic year.

All transfer values are based upon student movement across institutions and represent a change of institution in which a student is enrolled. This does not necessarily represent formal transfer activity (e.g., where academic credits are recognized between institutions).

Graduation rates at four-year public colleges and universities give the percentage of the Fall 2015 cohort of first-time, full-time undergraduates at four-year public colleges or universities who graduated or transferred within six years. Institutional rates include students initially enrolled at the institution who received a bachelor's degree from any public or state-aided-independent college or university in the State. Statewide rates represent students enrolled at any public four-year institution who received a bachelor's degree from any public or state-aided-independent college or university in the State. Pell grant recipients are students in the Fall 2014 analysis cohort who received Pell at any time during the 2014-2015 academic vear (cohort vear correction added January 2023).

Community college graduation and transfer rates give the percentages of first-time, full-time students in the Fall 2016 cohort who graduated or transferred within four years.

Community college "Graduated and Transferred" rates represent students who graduated with an associate degree or lower-division certificate and transferred to a Maryland four-year college or university.

Community college "Graduated/Did not Transfer" rates represent students who graduated from a Maryland community college with an associate degree or lower-division certificate and did not transfer to a Maryland four-year institution.

Community college "Transferred to Four-Year College or University without Graduating" rates represents students who transferred to a Maryland four-year institution without having completed an associate degree or lower-division certificate.

Community college graduation and transfer rates for Pell recipients include students in the retention and graduation cohort who received Pell at any time during the 2016-2017 academic year.

The number of community college students transferring to four-year public institution figures include students enrolled in a community college during Fall 2019 who subsequently enrolled in a four-year public college or university during Fall 2020.

The Degree Progress Analysis is a model used to report the progress toward degree completion of community college students and incorporates developmental education needs and completion, intentim measures of success, and transfer to other institutions including private and out-of-state institutions as indicators of progress. Detailed institutional reports are part of the annual Performance Accountability Report submissions.

The Degree Progress Analysis cohort includes full- and part-time students who attempt at least 18 credit hours (including developmental courses) within the first two years after initial matriculation.

Student outcomes for the Degree Progress Analysis are identified based on student data obtained by institutions from the National Student Clearinghouse, and include student enrollment and graduation activity at both in-state and out-of-state institutions.

Totals for the Degree Progress Analysis reflect summation of cohort data as reported by the colleges, and derived percentages are based solely on the reporting institutions.

For the Degree Progress Analysis, "College ready" are students who were assessed not to need remediation in any subject area. "Developmental completers" are students who were assessed to need remediation in at least one subject area and completed all required coursework.

"Developmental non-completers" are students who were assessed to need remediation in at least one subject area and did not complete all required coursework.

For the Degree Progress Analysis, "Successful persisters" are students who, within four years after initial enrollment, have completed at least 30 credit hours with a GPA of 2.00 or better, have graduated and/or transferred, or are still enrolled at the institution.

Dearees

Degree data exclude all certificates other than Lower-Division Certificates (i.e., Upper Division Certificates, Post-Baccalaureate Certificates, and Certificates of Advanced Study). Additionally, students earning multiple degrees at the same level but in multiple majors (e.g., a Bachelor's Degree in two different subjects) are counted once for that degree level. Students earning multiple degrees at multiple levels (e.g., both a Bachelor's Degree and a Master's Degree) are counted at each degree level.

First-professional degrees are included in doctoral degree figures.

Degree major programs are defined using the HEGIS (Higher Education General Information Survey) classification system, with Maryland's unique alterations, Program codes are established by MHEC, based upon institutional recommendation, at time of programmatic approval.

Faculty and Staff

Faculty and staff may be employed at more than one institution. They are included in figures for each institution by which they are employed.

Faculty and staff categories are based upon IPEDS Principal Occupational Assignment classifications. Employees classified as Graduate Assistants - Teaching (IPEDS Category 19) are not included in either faculty or staff figures.

The faculty category includes those classified as Instruction (IPEDS category 15) and Instruction combined with Research and/or Public Service (IPEDS category 16). Faculty members categorized as Research (IPEDS category 17) or Public Service (IPEDS category 18) are not included in these figures. Additionally, pre-clinical and clinical medicine faculty (IPEDS Program Assignment category 98) and Continuing Education faculty (IPEDS Program Assignment category 96) are excluded from faculty totals and salary figures.

The staff category excludes all employees classified as Instruction, Instruction Combined with Research and/or Public Service, Research, and Public Service (IPEDS categories 15, 16, 17, and 18), and Graduate Assistants - Teaching (IPEDS Category 19).

Campus and segment salary averages are weighted by the number of faculty at each rank at each institution.

Montgomery College identified a potential issue with staff race/ethnicity data reporting that may affect the comparability of prior years' data.

Revenues and Expenditures

Revenues and expenditures represent 2021 actuals.

Community college revenue and expenditure data are obtained from the audited institutional Annual Financial Reports to the Maryland Higher Education Commission. Baltimore City Community College data are based upon preliminary unaudited data because the audited report was not available at the time of publication.

Four-year institution revenue and expenditure data are as submitted for the 2023 Budget Book.

Full-Time Equivalent students (FTEs) are calculated using a formula applied to full-time and part-time students.

The Coronavirus Aid, Relief, and Economic Security Act (CARES Act) provided funding to colleges and universities as supplementary institutional support and for emergency student financial aid. This funding is excluded from FY 2021 revenue figures.

Community college revenues exclude revenue from auxiliary enterprises and local in-kind appropriations.

Community college "Other" revenue includes State and local grants and contracts, private gifts, sale of educational activities, other sources, and transfers to and from the fund balance.

Four-year public college and university "Other" revenue includes State, local, and private grants and contracts, private gifts, sale and services of educational activities, other sources, and transfers to and from the fund balance.

University of Maryland Global Campus revenue and FTE figures include overseas tuition revenues and FTEs.

Four-year public college and university expenditures exclude auxiliary and hospital expenditures.

"Institutional support" includes expenses for the day-to-day operational support of the institution. This includes expenses for general administrative services, central executive-level activities concerned with management and long-range planning, legal and fiscal operations, space management, employee personnel and records, logistical services such as purchasing and printing, and public relations and development, along with information technology expenses related to institutional support activities.

Figures reflect original authorization amounts. Subsequent budgets may reflect adjusted authorizations.

Tuition and Fees

Institutions may revise tuition and fees after initial approval. Final tuition and fee rates may differ.

Tuition and fees data are prepared by the Maryland Association of Community Colleges (MACC) and published in the annual MACC Data Book. Community colleges provide MACC with annual tuition and fees for full-time students.

Average community college tuition and fees are based on dividing what a full-time student taking 30 credits in an academic year would pay on a "per credit" basis. Tuition and fee charges at some institutions may vary based upon a student's enrollment, so the actual "per-credit" tuition and fees for an individual student may vary slightly from these institutional data.

Community college "service area" is defined by the institution. A number of community colleges have reciprocal agreements with other jurisdictions, allowing residents of those areas to pay a reduced rate.

Four-year public college and university undergraduate tuition rates are based on the "standard" undergraduate tuition and fees schedules. Some specialized academic programs may charge differential rates, which are not included. The University of Maryland, Baltimore average reflects the unweighted average of undergraduate programs.

Four-year public college and university graduate tuition rates are based on the "standard" graduate tuition and fees schedules. Some specialized academic programs may charge differential rates, which are not included. The University of Baltimore and University of Maryland, Baltimore are excluded due to widely varying tuition rates, along with St. Mary's College of Maryland, which offers a fixed-price graduate program with differing credit requirements based upon academic track.

Financial Aid

Total aid and average aid per student calculations are based upon all students; students enrolled at multiple institutions are included in all instances in which they received an award.

Calculations of the characteristics of financial aid recipients are based upon a financial aid file unduplicated at the statewide level. For the analysis, students receiving aid from multiple institutions are assigned to one institution based on standardized methods.

Data include only students receiving undergraduate aid and do not reflect the entire student population, as students not receiving aid are not included in the data file.

Data reflect student financial aid awarded by institutions. Some students may have been awarded aid that was not disbursed.

All aid programs use a unique code. Those codes are used to create aid categories and to delineate graduate and undergraduate aid.

Students may receive aid at both the undergraduate and graduate levels. Only undergraduate-level aid is included in tables for financial aid awards at community colleges and public four-year institutions.

The "Other" Race/ethnicity category includes students identifying as American Indian/Alaska Native, Native Hawaiian/Pacific Islander, and Two or More Races. It also includes foreign students and students with a Race/ethnicity that is unknown.

Students are identified as "dependent" or "independent" based upon information contained in their Free Application for Federal Student Aid (FAFSA). Dependent student status and independent student status do not sum to 100% as not all students file a FAFSA form.

Adjusted Gross Income and Average Need are calculated using information obtained from the FAFSA. These data may be incomplete for those students who do not file a FAFSA form.

Financial aid program expenditures reflect actual awards made to students in FY 2021. Prior year adjustments may be included in award amounts.

Financial aid program expenditures include all undergraduate- and graduate-level aid awarded through Maryland financial aid programs. This includes aid awards made to students at community colleges, four-year public colleges and universities, independent institutions, other private institutions, and private career schools, dependent upon program eligibility criteria.

In reporting program expenditures, the number of recipients includes those who received the award; not all students who are awarded aid accept if

COVID-19 aid includes all temporary aid categories established as a result of the COVID-19 pandemic. This includes aid from all sources (e.g., federal) and all aid types (e.g., grants, scholarships).

Private Career Schools

Some private career schools that continue to operate in Maryland have been omitted from this list because data was not submitted by the deadline.

Subsequent school closures may have taken place prior to publication. Data may be missing due to school closures and data may be present although a school is no longer in operation.

Enrollment represents students enrolled from July 1, 2019 through June 30, 2020.

Distance Education

COVID-19 had a significant impact on the methods institutions used to deliver coursework. Institutions were asked to identify instructional modalities based upon the intended delivery method; however, institutions differed in the ability to do so. Some institutions may have under- or over-reported distance education offerings and enrollments due to this issue.

Data are submitted by institutions in a survey aggregated to the institutional level. Due to the method of collection, it is not possible to track student enrollment across institutions. Students are included in figures for each institution at which they are enrolled.

Distance education includes all course delivery methods where at least 100% of the instruction/interaction is technology-mediated and/or electronically-delivered.

Distance education enrollments include all instances of enrollment in distance education courses. Students enrolled in multiple courses are counted for each course in which they enrolled.

Distance education credit-bearing course sections include all credit-bearing sections offered by distance education methods during the calendar year. Totals may include multiple sections per course.

Headcount student enrollment is unduplicated at the institutional level. Each student is counted only once throughout the calendar year, regardless of the number of terms or the number of courses in which a student enrolled.

"Traditional Only" student headcounts include those students enrolled in traditional classroom-based courses only, which have 100% or more of their instruction/interaction in a traditional classroom or face-to-face setting, with specified meeting times and a standard location.

"Distance Only" student headcounts include those students enrolled in courses delivered via distance education only during the time period specified.

"Mixed - Both Distance and Traditional" student headcounts include those students who enrolled in at least one traditional classroom-based course and one distance education course during Calendar Year 2020.
